Mr. Jamie Maguire currently serves as Chairman and Chief Executive Officer of Philadelphia Insurance Companies (PHLY). He began his 25-year career in insurance as a broker & underwriter of professional liability, working for prominent U.S. P&C insurance companies in New York, Chicago & Philadelphia before joining PHLY in 1996 as a Vice President of Underwriting. In 1999, he was promoted to Executive Vice President & COO, before becoming President & CEO three years later. Under his leadership, PHLY has received multiple 'Best Places to Work' awards and has seen revenues grow from \$460 million to over \$2 billion, propelling its stock to a high of \$61.50. In December of 2008, Mr. Maguire and his management team successfully initiated, negotiated and completed the merger with its current parent, the Tokio Marine Group, the fourth largest P&C insurer in the world. He was subsequently named President and CEO of Tokio Marine's U.S. Operations, TMNA Inc. Following the merger, PHLY has remained among the top P&C insurers in the country, achieving an "A++" AM Best rating in 2011 for its consistent superior results.

Mr. Maguire received his B.S. in Finance from Saint Joseph's University and MBA from the University of Notre Dame. He serves on the Boards of the American Red Cross SEPA Chapter, the Franklin Institute, Breakthrough of Greater Philadelphia, Saint Joseph's University and the Saint Joseph's University Academy of Insurance & Risk Management. He was named the 2010 Ernst & Young regional 'Entrepreneur of the Year' and received the 2008 Emerald Advisors' Entrepreneurial and Excellence Award. When not driving financial results, he competes in endurance races and has completed 15 half Ironman, 8 full Ironman (including the Ironman World Championship in '03 and '06), numerous marathons/half marathons and the 2011 Leadville Trail 100 mountain bike race. He and his wife reside in Fort Washington, PA with their four daughters.
