Monthly Reporting
Average Number of Automobiles in Fleet Calculation Example

Facts Assumed for this example:

30	Days in the reporting month
20	Vehicles owned for all 30 days of month
2	Vehicles owned for 25 days of month
3	Vehicles owned for 5 days of month

Step #1

Multiply the number of vehicles owned by the number of days owned.

20 x 30	=	600 car days
2 x 25	=	50 car days
3 x 5	=	15 car days
Total	=	665 car days

Step #2

Take the total car days and divide by the number of days in the month. ($665/30 = 22.17$) is your “average number of automobiles in the fleet”. The “average number of automobiles in fleet” figure should then be rounded to the nearest whole number. In this example, the figure that should be listed on your “Monthly Premium Reporting Form” is 22.

Please report only whole numbers on your reporting form.

RESIDENTS OF OREGON APPLICANTS: "ANY PERSON WHO KNOWINGLY AND WITH INTENT TO DEFRAUD OR SOLICIT ANOTHER TO DEFRAUD AN INSURER: (1) BY SUBMITTING AN APPLICATION, OR (2) BY FILING A CLAIM CONTAINING A FALSE STATEMENT AS TO ANY MATERIAL FACT, MAY BE VIOLATING STATE LAW."

RESIDENTS OF PENNSYLVANIA APPLICANTS: "ANY PERSON WHO KNOWINGLY AND WITH INTENT TO DEFRAUD ANY INSURANCE COMPANY OR OTHER PERSON FILES AN APPLICATION FOR INSURANCE OR STATEMENT OF CLAIM CONTAINING ANY MATERIALLY FALSE INFORMATION OR CONCEALS FOR THE PURPOSE OF MISLEADING INFORMATION CONCERNING ANY FACT MATERIAL THERETO COMMITS A FRAUDULENT INSURANCE ACT WHICH IS A CRIME AND SUBJECTS SUCH PERSON TO CRIMINAL AND CIVIL PENALTIES."
